### Smith Anderson Lobbyist Tops State Rankings

**RALEIGH** – The Smith Anderson law firm has North Carolina's top lobbyist and one of its highest-rated Government Affairs teams, according to a new ranking of the state's best lobbyists.

Smith Anderson partner Dana Simpson ranked first among 798 registered lobbyists in the biennial survey by the independent, nonpartisan N.C. Center for Public Policy Research. At 38, Simpson is the youngest lobbyist ever to claim the top spot.

"This ranking, although certainly gratifying, is not an individual achievement," Simpson said.
