OVERVIEW

Jackson's government contracting practice includes dispute resolution, including pre- and post-award bid protests of federal and state agency procurements; practicing before the Government Accountability Office (GAO) and the Small Business Administration (SBA) Office of Hearings and Appeals (OHA); pursuing Requests for Equitable Adjustment (REAs) and claims before the Civilian Board of Contract Appeals (CBCA), the Armed Services Board of Contract Appeals (ASBCA) and state and federal courts; and litigating contractor disputes with other private businesses. His compliance work helps clients to navigate the provisions of the Federal Acquisition Regulation (FAR) and agency subparts (including the DFARS) as well as state of North Carolina requirements.
